Builder's Corner: Is there a proper way to mount propellers in a twin screw installation? You bet!

Piloting, Seamanship and Small Boat Handling by Chapman states: "...the ideal arrangement is to have the tops of the blades turn outward for better maneuvering qualities." A recent posting on America Online (rec.models.rc.water) by Joseph Benning made the same point, adding: "inboard turning creates turbulence which cavitates around the propellers and hull. This energy is wasted boiling water with low pressure, instead of moving the vessel."

Columbus Day Regatta: Well folks, another (the fourth annual) Columbus Day Regatta is in the history books. With overcast skies and a northwest wind of about six miles per hour it made for perfect sailing conditions. A little cold on the hands but great winds. Jeff McCabe burnt up the course with a whopping 215 points. Dick Kjellberg finished second with 185. Out of all the regattas I've seen, I can't remember having ten boats reach the first mark all at the same time. It was very interesting on that first turn! To all the skippers who showed up to race, thank you! It was an awful lot of fun! Bob Jester got his hands on one of the old rental boats and raced with us. Not bad, Bob, for the first time! Sailing: The art of running, reaching, tacking or jibing while freezing, sweating, swatting or swearing.

Another Sticky Subject: Cyanoacrylate (CyA) type glues such as Zap™ and Hot Stuff™ can be stored (unopened) in the refrigerator to extend their shelf life. But, storage in the freezer extends shelf life almost indefinitely. The container should be allowed to warm slowly to room temperature prior to opening. (Try not to get it mixed up with the salad dressing!)

Board Meeting, 9/19/95: Commodore, Kjellberg called the meeting to order at 6:30 PM. Bottemiller, McCabe, Olsen were present, along with park director, T.Shirley. Commodore asked T. Shirley if the city had paid any of the expenses of the CR-914 Regatta. Tom replied that no funds had been advanced, however R.Peter had approached him in early September to pay for the advertising-sponsor banner. Tom had agreed to pay the \$370 cost, but had not paid, as yet. Board suggested that funds not be paid until a full accounting is made by R.Peter. Financial numbers are expected at this meeting. P.Olsen advised Tom that the EMYC does not want two boating clubs at Centennial. Tom agreed that bylaws preclude this. It was stated that Tom should not deal directly with R.Peter but conduct and verify all business with the duly elected club officers. Bottemiller stated that the Board has received absolutely no information on the race or the financial specifics of the event. Kjellberg stated that R.Peter is presently involved in a legal dispute with the Two Guys From Italy restaurant for non payment of reservations for the regatta banquet. He stated that he hoped that the lawsuit would not jeopardize the club's relationship with the park. Tom said that it would not. McCabe advised Tom of the electric event on Sep.23rd. No problem on that item. Kjellberg asked for the Centrum building room for our regular (Oct.17th) meeting. Room is available. (T.Shirley departed about 6:45 PM). P.Olsen suggested that the club pay the Two Guys for the forty reservations, even though only 19 attended, in order to preserve the club's good name with the Centennial Lakes merchants. About this time, R.Peter arrived and was asked for his financial statement. He stated that he had "run short" by \$50. McCabe requested the income and expense reports on the 914 regatta. Olsen said that an accounting was necessary, R.Peter stated, "I don't have the numbers with me." McCabe demanded to know when the 'numbers' would be available. R.Peter stated that he would have them "by the weekend" (9/21-22). R.Peter's explaination of the Two Guys lawsuit was that they agreed to cater the banquet and reservations were made for 40 persons. He wrote a check to Two Guys for 40. When only 19 people showed up for the banquet, R.Peter requested a refund for the 21 unused reservations. Two Guys said that they had turned away reservations on account of the 40 banquet spaces reserved and denied the refund. R.Peter stopped payment on the check and issued a replacement, paying for only the 19 who attended. Two Guys have filed a small claims court suit for the balance (\$233). Olsen made a motion for the club to pay the balance now, in order to show good faith. Kjellberg stated that it was his opinion that to stop payment on a check for a legitimate bill was a crime. R.Peter stated that he did not want the club to pay. He wanted to go to court. The club could pay later, if he lost the lawsuit. McCabe said, "No, we will pay now, if you continue with the suit, and loose, we will not pay." Olsen said that since restaurants must plan ahead for reservations, and even though the facility was "not full", according to R.Peter, the bill for the 40 reservations was legitimate, Olsen and McCabe voted in favor of payment. Vote passed. Club will pay the bill. New business: Kjellberg suggested that the Dry Dock Party be made free to

members this year. Pay only for guests. Motion made and passed. A firm date for confirmation of reservations will be set in order that a reliable count can be obtained. Suggested guest cost will be about \$6.

Adjourn, 6:58 PM.

Membership Meeting, 9/19: To order at 7:00 PM. Eighteen members in attendance. J.Smith read an open letter to the Board requesting answers to several questions asked of him by members during the five weeks since the 914 regatta. R.Peter left the meeting. In reply to Smith's and other members questions, Board members stated that they were told the regatta would be a "no cost" event to the club. Sailing clubs from lake Minnetonka would be asked to officiate. Sponsors were not to be solicited. Board expressed concern when it appeared that their direction was not being followed. Sponsorships actually cost more than they afforded in revenue. R.Peter refused assistance from the Board and from individual members. Assistance from outside clubs and from our own 914 owners did not materialize. Financial figures on the event were to have been presented at this meeting. They were not received. E.Stevenson suggested that a solution was necessary. "A commitment is made when reservations are made. Two Guys bill should be paid", he said. C.Bottemiller suggested that every event should have a board member as an overseer in order to preclude a repeat of the problems encountered at this event. P.Olsen stated that the entire Board attempted to oversee this event but were ignored at every attempt. It was suggested that any member who wishes to have a future event that might include a financial commitment by the club present hard figures to the Board and supply continuing information and receipts throughout the planning process.


