Nomination of Officers: Nominations for the position of Commodore, and seperately for the various Board positions will be accepted from the membership at the club meeting on September 17th.

Carefully consider the person or persons whom you would like to see leading our organization during the next twelve months. We would like to have at least two members interested in the position of Commodore to accept nomination, and five or more willing to accept for the four Board member positions. Any current member may be nominated to either or both of these positions. Although a member may nominate himself or herself, all nominations do require a second. If your nominee is unable to attend the meeting, please determine his or her willingness to serve prior to placing their name in nomination. All members in good standing are eligible for nomination (The present Commodore, having served two consecutive terms on the Board, is ineligible).

Those accepting nomination will be asked to submit a short, written position statement on a form which will be distributed at the meeting, and return it to the newsletter editor prior to October 1st. Statements will be published, along with the ballots, in the October newsletter.

Mailed in ballots will be counted at, and new officers introduced at the Dry Dock Party in November. Term of office will run until the Dry Dock Party of 1997, or December 31, 1997, whichever occurs first.

Contest Report...Times Two: On August 3 & 4, Dick Edge, myself and our wives entered the model boat contest in Manitowoc, Wisconsin. We had no idea what to expect, and after two days of lectures and discussions, you could sense that they were experts. There were 40 boats entered. Dick got awards for his catamaran and cruiser, I got an award for my steamboat. Unfortunately, the fish tug got nothing.

Typically, their boats were scratch built, all blocks, etc. were hand machined, and when it was all done, they built a glass case to go around it. It was fun to be around these people for two days.

They have the same problem we do, how to get rid of the models...but theirs are worth a lot more in time and money. In my case, I drove up to Gills Rock and gave my tug to the local fishing museum.

Considering that between Dick and I we had four of the five radio controlled models entered, it was mostly a scale model contest, but there certainly were some beautiful models.

The Wisconsin Maritime Museum 20th annual Model Ship and Boat Contest was held on August 3rd and 4th with two EMYC members in attendance. Glenn Anderson and his wife, Hildegard plus Dick Edge and his wife, Doris, made the trip. It is a six and one-half hour drive if you leave at four in the morning plus a breakfast stop in Wausau, so it makes for a very long day.

Glenn entered his Great Lakes fishing boat, *Hildegard*, and his paddle oar steamer the *John Fitch*, and received a merit award for the latter. Dick entered his *Trojan* Cruiser and *Wildcat* Catamaran and received merit awards for both in the Novice class. There were some twenty-five contestants who entered a total of forty-four vessels, of which only eight were of operating class with the balance made up of scratch or modified kits of static class with some in glass showcases.

A Saturday symposium was held on modeling and was hosted by Reverend Bob Thomton and Mr. Frank White. Awards and pictures were taken on Sunday afternoon by Model Ship Builder Magazine and the Maritime Museum. The awards were based on a historical account paper, a construction paper and overall appearance of the model.

Manitowoc is a city of thirty-two thousand people with lots of flower gardens, a producer of aluminum ware and home of the Lake Michigan carferry, the SS Badger. We recommend the Inn on Maritime Bay for lodging. It has a good pool and a fine dining room with a view of the lake.

The hombound trip on Monday required a stop in Green Bay to see the Green Bay Packers football team work out and a stop in Pulaski, WI to the Carver Boat Factory, the parent to the *Trojan* Cruiser of Sarasota, FL. In all, it made for an eventful weekend. (Next year's Contest is scheduled for August 2 & 3, 1997)

**Speed vs. Duration:** Recently, Dick Kjellberg had a friend draw him a wiring diagram for a series (speed), parallel (duration) battery arrangement for use in his fast electric boat. The diagram showed two separate switches which appeared to me to be easily incorporated into one. I consulted John Bishop, our resident wiring wizard, and he consented to redraw the circuit using only one switch, albeit a double pole double throw (DPDT) unit. I also asked John to draw up a circuit that would duplicate Tom O'Dell's "Hyper Thrust" device, (Astro 40, 12 volt lead acid battery and a seven cell Ni-Cd booster battery for a total of twenty volts). If you missed the performance of that gadget back in April, it would be worth a trip to St. Louis just to see it in action.


The series/ parallel circuit should use two batteries of the same voltage and mAh size, while the second battery in

the 'hyper thrust' version can be of any size since it is only used in series and then, only intermittently.


Two cautions come to mind. Use switches of high capacity, since large current surges will take place when either of these devices is activated. Arcing within the switch will contribute to a short life span and a higher capacity switch will last longer. Second, make certain that the speed control and/or battery eliminator circuit in use can handle the sum of both battery voltages added together and that the speed control can also manage the high amperage which is inherent in a higher voltage situation. It can be very expensive to replace fried MOSFETs!

Of course, you will also need a spare radio channel and additional servo to operate either of these devices.
